ELIGIBILITY

- A. Regular members of FAMOS are Filipino-American Officers of the United States Armed Forces on Active Duty, Retired, Reserve, and any commissioned officer who served honorable military service.
- B. Former U. S. Navy Limited Duty Officers (LDO) who prior to "permanent status" and reverted to "enlisted status" for pay purposes upon retirement are considered "Retired."
- C. Eligibility is also open to other Asian and Pacific Islander American Military Officers meeting the eligibility requirements under Section 1A and 1B of FAMOS Constitution & Bylaws. Asian and Pacific Islanders should be no more than 20% of the total membership.
- D. Eligibility is also open to other Military Officers married to an individual of Filipino descent and meeting the eligibility requirements under Section 1A and 1B above but limited to no more than 20% of the total membership.

- E. Applicants become a full-fledged member upon submission of an application, payment of established dues, upon recommendation of the Membership Committee, and approval of the Executive Council. Applications may be submitted to any officer of FAMOS and with appropriate dues paid to the Treasurer.

CATEGORIES OF MEMBERSHIP

- A. Charter Members. These are members in good standing whose names appear on the membership roll as of 19 May 1990.

- B. Regular Members are members meeting the criteria as defined in Section 1A, 1B and 1C of Section 1 above.

C. Associate Members shall be:

1. Spouses of Regular and Associate Members
 2. Any Filipino-American in Civil Service Pay Grade GS-11 or higher who has served or is serving in a supervisory position with the Department of Defense (DOD).
 3. Any Filipino-American who has served or is serving as E-9
 4. Eligibility is also open to any former or present E-9 whose spouse is of Filipino descent.
 5. Associate members shall pay the regular annual dues and may hold any office except the Presidency and Vice Presidency.
- D. Honorary Members are recommended by the Membership Committee and approved by the Executive Council with no more than 10% of the total membership.
- E. Student Members are persons who are attending ROTC, Jr. ROTC or Military Academy.
